CAR RENTAL AGREEMENT

The car agreement is hereby made between

The owner hereby agrees to rent the following vehicle to the renter:

The Renter will rent the car from date _____ at _____ to date _____ at _____. The Renter agrees to pay fee of _____ thai baht for this period of time. The deposit in the amount of 10 000 baht, will be kept during the rental period. The owner must retain this deposit, for use in the event of loss or damage to the vehicle, during the term of this agreement to fully or partially offset the cost of any necessary repairs or replacement. In the absence of damage or loss said deposit shall be returned to the renter.

The Renter agrees to return the vehicle in its current condition to the Owner on the return date and hour with same fuel (E-20) in the same location, where car was given to renter.

The Renter understands that the vehicle is for use only in Thailand locations and cannot be taken outside the country.

The Renter swears and attests that he has a legal, valid license to drive this vehicle in this country, and there are not outstanding warrants against said the license.

The Renter agrees not to allow any other person to drive the vehicle, except for authorized drivers listed and approved here: _____

The Renter agrees to use the vehicle only for routine, legal purposes. The Renter further agrees to follow all city, state, country and government rules and restrictions regarding use and operation of the vehicle.

No smoking in the car, otherwise the deposit will be fired.

The Renter agrees to pay all fines, received during the rental period. Existing damage to vehicle: noted on video, photo.

Insurance

Car has first class insurance of Viriyah Insurance Company Thailand. In the event of accident insurance will cover under following policy, but the deposit will be not returned to the Renter, excludes some terms: a) If there is a scratch on the car cause by the rentor, during contract amount of 5 000 will be charged form the deposit money. If there is a dent on the car cause by the Renter, during contract amount of 10 000 will be charged from the deposit money.

If the car has accident in total damage which is not repairable or repair cost more than 50% of

total cost of the car, or in case of theft of the car, then the tenant must pay the cost in the amount of 100 000 THB as compensation to the Owner of car in 5 days, after the accident. In case of delay in compensation payment for damage, an additional fee of 1% daily will be charged.

Indemnity

Regardless of insurance coverage, Renter shall fully indemnify the Owner for any loss, damage and legal actions, including reasonable attorneys fees that Owner suffers due to the Renter's use of vehicle during the term of this Agreement, including but not limited to, damage to the vehicle, damage to the property of others, injury to Renter, and injury to others. This provision survives the termination of this Agreement.

Owner Warranty

The owner represents that to the best of his knowledge and belief that the vehicle is in sound and safe condition and free of any known faults or defects that would affect its safe operation under normal use.

Renter Warranty

The renter agrees will not use: a) the vehicle to push or tow another vehicle; b) the vehicle for any race or competition; c) operate the vehicle in a negligent manner; d) operate the vehicle in violation of any laws or for an illegal purpose and that if Renter does, Renter is responsible for all associated, tickets, fines and fees.

Disputes and Government Law

The laws of Thailand Kingdom without regard to any conflict of law principles govern this agreement. No action, arising out of the transactions under this Agreement may be brought by either Party more than one year after the cause of action has accrued.

General

This Agreement, including all Exhibit(s), constitutes the entire agreement between the Parties in connection with the subject matter hereof and supersedes all agreements, proposals, representations and other understandings, oral or written, of the Parties and any current or subsequent purchase order(s) provided by Affiliate. No alteration or modification of this Agreement or any Exhibits shall be valid unless made in writing and signed by an authorized Affiliate of each Party. The waiver by either Party of a breach of any provision of the Agreement shall not operate or be construed as a waiver of any subsequent breach and any waiver must be in writing and signed by an authorized Affiliate of the Parties hereto. If any provision of this Agreement is held to be invalid or unenforceable, the remaining provisions shall continue in full force and effect. Any notice or other communication required or permitted hereunder shall be given in writing to the other Party at the address stated above, or at such other address as shall be given by either Party to the other in writing. Any terms of this Agreement which by their nature extend beyond its termination remain in effect until fulfilled, and apply to respective successors and rightful assignees.

Other Terms

- a) In the all other condition that are not regulated by this agreement, the parties are guided by the current legislation of the Thailand Kingdom.
- b) The contract is made in two copies, having equal legal force.
